### What is a Traffic Guidance Scheme?

A Traffic Guidance Scheme is a diagram that illustrates the arrangement of signage and devices used to manage traffic at your worksite. The plan will detail the location and spacing of all signage and devices, pavement markings, any containment fencing and barriers, arrow boards and/or variable message signage, and roadwork speed zones.

- After determining your specific needs, we'll prepare the most appropriate Traffic Guidance Schemes for you. Our qualified traffic control specialists will tailor, develop, and implement your customised traffic guidance schemes, allowing you to be more productive and to get on the job.

# Traffic Management Plans (TMP) / Construction Traffic Management Plans (CTMP)



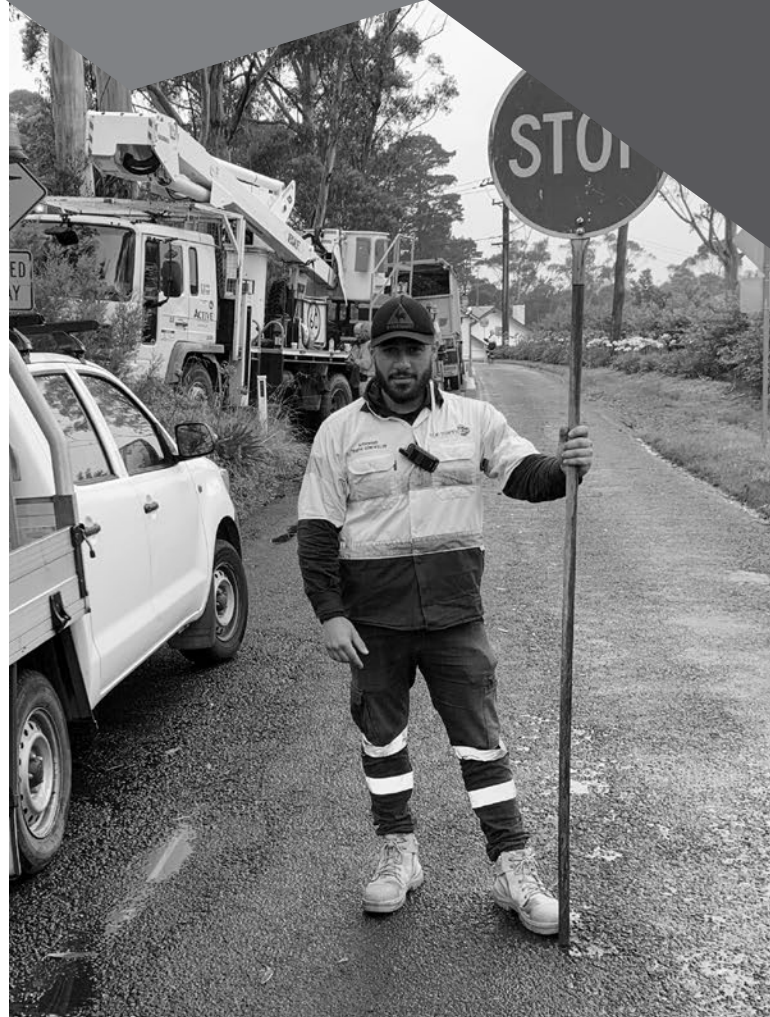

A Traffic Management Plan (TMP) or Construction Management Plan (CTMP) is a report detailing the work to be undertaken and the impacts the work will have on the general area. It also details how these impacts are to be addressed and may include a number of Traffic Guidance Scheme (TGS).

## What is it required for?

A TMP/CTMP will usually be required for a Development Application or for a larger scale event/project.

- The Traffic Controllers make every effort to prepare and design our Traffic Management Plans (TMPs) and Traffic Guidance Scheme (TGSs) in proportion to the job being undertaken. Our plans therefore can vary from easily recognised generic layouts to extremely complex designs for staged or long-term works. No matter what the scale, we always aim to provide solutions that minimise complications and maximise your productivity and efficiency but that never compromise on safety or quality.
- Our SafeWork NSW accredited Traffic Management Designers (TMDs) make every effort to meet or exceed our client's expectations even if it is only a draft proposal. The availability of precise information and project requirements speeds up the process however, the planning time frame will depend on the complexity and scope of the project
- We guarantee that you, the client, will be assigned an experienced traffic control coordinator who will



supervise and oversee your project from beginning to completion. We place huge emphasis on regular face to face site meetings as it allows us to not only gain a thorough understanding of the project from the outset but also of any changes or risks that arise during the course of the works.

Construction sites are dynamic by nature and therefore we develop our TMPs and TGSs, taking into account the sequence of works and type of project. However, where changes to a project or sequence of works impacts on any temporary traffic management arrangement, our accredited Traffic Management Designers ensure that these changes are incorporated into the site specific TGS and are communicated to all relevant parties.



## Permit Application And Authority Liaisons
